1. Property acquistion update

Megan Olds from the Conservancy joined us by phone. She reported that we have \$523,000.00 to raise in matching funds for Phase I. She said the Conservancy has had some promising conversations with local foundations that we will be working with in 2010

We will be applying with the Carls Foundation for \$150,000.00 in the Spring. This will be a challenge grant. Olds has always been in contact with the Dow and Mott foundations. Dow is a June application and Mott is a March.

2. Fundraising update

Brink reported that the cultivation event scheduled for the previous evening, December 8th had been cancelled. To Too many commitments this time of the year. Brink and Salathiel reported sending out thirty letters the day before to possible donors. Guy said we are in the "silent not secret" phase of this campaign. The emphasis is on getting larger donations now and then broaden out to the public. Olds suggested a meeting of the Finance subcommittee before the next scheduled monthly meeting. It was decided to have a meeting at 3:00 p.m. on January 13, 2010, before the regular scheduled meeting at 4:00–4:30 p.m.

3. Marina update

Aukerman reported that the Request for Qualifications/Proposals (RFQ/P) was completed. This is for the Marina Feasibility study. The notice will be published in the Record Eagle December 10-16th. It is also available on the township website. The deadline for accepting proposals is 5:00 p.m. January 4, 2010. Interviews are scheduled to be held January 27-28th.
