B. APPROVAL OF AGENDA:

There was a discussion about having additional agenda items on agenda. Trustee Scott expressed concern since he thought that this was just a special budget meeting, but was now seeing four additional agenda items. Supervisor Zollinger said the agenda was posted on the Web and posted as required so we could make use of a meeting to conduct Township business. Trustee Scott expressed concern about adding these items to the agenda, he understood having bill payments for our Capital Improvement bonds, but not audit direction and two shoreline park resolutions on the agenda. 2. Discussion on second draft of 2013-14 Acme Township Budget so public hearing date can be set - Zollinger

Discussion on second draft of 2013-14 Acme Township Budget so public hearing date can be set for June 4, 2013. Minor corrections were made to various line items and corrections will be made. A list of questions about various items was asked of the Supervisor. Trustee LaPointe requested more detail on Parks & Recreation expense, what requirements are there to qualify for Acme Township's 401K plan and a request for a breakdown of our retainers for Beckett & Raeder and Attorney Jocks. Trustee Scott raised the question of what the supervisor's pay was when the Township manager's position was created. Supervisor Zollinger will provide answers to these questions. There was discussion about pay for elected officials. A summary was provided of how Acme Township's pay compares with other similar townships.
