b) Traverse Bay <u>RV Park Site Plan/SUP Extension of SUP 2011-01P</u>

Fred Campbell spoke on the history of the SUP and the fact that the SUP has lapsed. With the economy returning they would like to re-up their application. Their request was for two years and due to the stipulations of the zoning ordinance, it can only be extended for one year.
