a) <u>Application # 2008-03Z for Scott & Karen Burdick, 4293 Five Mile Road,</u> Williamsburg, for extension of Nonconforming Use of Structure under Section 9.5 for residence at the above address.

Kuncaitis read the published hearing notice into the record. Kuncaitis said there are three parts to this application. Kuncaitis said the Applicant seeks to make two additions to an existing home that is grandfathered nonconforming; the applicant also seeks to rebuild an existing deck. The nonconformance is that part of the house sits in the front-yard setback; this request will not bring the building closer to the front lot line. Kuncaitis said the rebuild/repair of the deck falls under the protection of Section 9.4 so no action needs to take place. The second are proposed changes for a 3' x 34' expansion that would not encroach the setback. This is already a covered area. The roof will continue down over the exsiting roof in the expansion. The third. is a new porch, approximately 4'x12', that would encroach approximately 4' into the setback, 6' less than the nonconformance of the garage. The porch is next to the garage with a cement slab.

The applicant, Burdick, was present to show drawings and pictures and answer any questions the Board may have.

Hull has determined that all Basic conditions have been met.
